- 1. Around 2016 Started coming home to my apartment and finding someone was leaving grocery bags hanging off my door knob containing blu brand disposable e-cigs, did not think much about this at the time and thought it was a friend playing a prank or something. Happened several times over the course of two years, almost always what was in the bag was a blu brand disposable e-cig, I do not smoke cigarettes and still do not know who left them on my door handle. At the time I was employed as a Senior Software Engineer / Consultant for a company named Westlake Design/Westlake Interactive, as part of my employment duties I worked on many different client projects including American Health Networks intranet (internal medical directory website) and their external facing website. A major transporation / fleet management company used by many companies including tow truck companies to manage their vehicles, Westlake Interactive was purchased by another local software company Moser Consulting around 3 ½ years into my employment there. Moser Consulting does IT work for large corporations and government entities.
- 2. Around June, 2016 my next door neighbor who was employed by Fox59 news knocked on my apartment door and introduced me to a guy who she claimed was her younger sisters boyfriend, this guy told me his name is Mark and he was wearing an IU Health shirt, when he introduced himself he propositioned me for drugs which I don't do or sell and when I told him I don't sell drugs he repeated a false accusation where he said "How long have you been selling drugs for?" when I told him again that I don't sell drugs he repeated the same false accusation and said the same words again, then he tried to say more things like "Oh I get it you have to pay bills, I was a student once myself", I told him I'm not a student I carry a backpack with me every day because I am a software engineer and I have a macbook computer I take home with me from the office every day and some work from home and he eventually left my apartment and later on maybe a few days later, I spotted him actually making out in front of the apartment complex with my neighbor who worked at Fox59 news in Indianapolis and not her younger sister, this to me tells me they were never honest about who this Mark guy is.
- 3. 2014 2015 Checked my mail one day and I had received strange letter in the mail addressed to someone named Mr. Nabor, the letter was hand written and stamped but had no return address I still have this letter and original envelope, the letter read.

Go to Mayo Clinic "Ashen Skin" then go to a nearby cardiac hospital before it's too late SAVE YOUR LIFE!

I was unable to find who sent this letter, I confirmed with the apartment complex management that no one in the complex had the name Nabor and that it was dropped off in my personal mailbox and may have been sent through the post office but does not have a return address or any identifying name on it, a old friend of mine Phil Laraway left notes while talking on the phone on top of the envelope those notes are not relevant and were not made by myself or the envelope sender.

This letter seemed odd as back in 2014 Community North Hospital basically engaged in medical malpractice though the Respiratory doctors office as I suddenly when I started employment at Westlake Design came down with a weird medical issue where my body was creating too many white blood cells, this led to almost complete lung failure and my doctor there told me I needed to go the Mayo Clinic and when I scheduled everything through their office I was told that everything was ready and that my insurance company had been contacted and approved me going to the mayo clinic, and then I drove to the Mayo Clinic in Rochester Minnesota and when I arrived I was told my Mayo Clinic staff that there was never any approval for medical insurance through them which should have been handled by the respiratory doctor at Community North Hospital and I was told I'd have to pay for all their services without insurance, I couldn't afford to do this so I had to drive back home, this was a huge waste of money and time for me and seemed absurd that they told me it was approved by my insurance and then later I was told it wasn't. I contacted the hospital and respiratory office again and was told they would pay me for their negligence and offered to reimburse me for my expenses, however when I replied via email asking how they would reimburse me they suddenly stopped responding to me. Since 2014 by Community Norths communications with me they have been in debt to me and have been trying to discredit me. Attached to this timeline of events correspondence, is a scanned image of the letter I received.

4. 2016 – 2017 I was employed at Springbuk a local Indianapolis health care analytics company as a Senior Principal Software Engineer at a salary of \$105,000 per year. I was hired and onboarded directly by the Director of Software Engineering at the time a Mr. Mack Earnhart, a few days before my start day Mr. Earnhart decided to leave the company as he left his role at Springbuk he trained myself primarily and another Senior Software Engineer a Mr. Grey Bowman on how to setup and deploy all the encryption keys and chef automatic deployment scripts, for most of my employment at Springbuk I was responsible for my normal work duties as well as all of Springbuk's devops and infrastructure and even office network setup. I think during my fifth month of employment, a new Director of Software Engineering was hired named Steve Caldwell. From what I know about Mr. Caldwell's background is that before his employment at Springbuk and possibly during as well he co-managed a medical device startup called Strap HQ, this company I think was founded and registered in British Columbia, CA. During his employment at Springbuk Mr. Caldwell was living in Cincinnati, or Cleveland, OH and would work remotely some days and travel into the office other days.

Following his hiring there was a change in the overall team dynamics and productivity where suddenly team members would ignore my code review suggestions and ignore or refuse to review my code contributions, something that must be done by another team member before code could be pushed into the production environment.

Another colleague of mine Jordan commented on this as well that he had noticed things had changed when Mr. Caldwell joined the company. On March 3rd, 2017 I was let go from my position at Springbuk at the request of Mr. Caldwell, through a constructive dismissal. Mr. Caldwell pushed code out to the production environment during the night after Grey Bowman

and I both told him the code had not been tested and was not ready to be pushed to production, he ignored our warnings and sent the code out anyway, the following morning I came into the office and everyone was freaking out because production was broken, Mr. Caldwell falsely claimed the changes couldn't be rolled back and then blamed me and attempted to discredit me in our team slack chat in front of the other team members and then I told him he shouldn't have pushed those changes out. After being let go from Springbuk, I contacted a lawyer over wrongful termination using attorneys Fox Williams & Sink, and we sent a letter to them about how they didn't follow proper procedure and it was false accusation of wrong doing, later Springbuk settled in exchange and promised to only provide neutral references to anyone who inquired about my employment there and they reimbursed my \$1500 attorney fee.

5. 2015-2017 I started receiving harassment online people posting hateful messages on my open source software projects particularly my project Hamsters.js, this software is actually fairly successful and receives several hundred downloads per month and has even been mentioned in articles published by developers at IBM on the official IBM website.

As part of this harassment one individual violated the software license by copying the code and claiming it was his creation as well as the software website and re-branding it as his own product called Accel.js under the company name Three Letters, I ended up using an intellectual property lawyer John Roberts IP Law to defend against this the offending user moved the offending code to multiple web host, everytime he moved the offending code I filed either a DMCA takedown notice or contacted the hosting support company to notify them about the ip infringement, the lawyer I used at the time claimed that he used to be a private investigator in the past and told me he believed the user to be a guy named named Andrew Scheel, Mr. Scheel had two linkedin profiles with the same name and photo, one of these profiles noted he was employed as an investment banker for the Bank of America located in New York City, NY.

His other linkedin profile showed that he was employed as a Software Engineer at a company called Tableau software located in Seattle, Washington. After emailing Andrew Scheel with the draft copy of an official cease and desist notice Mr. Scheel took down the infringing code and then claimed to be just an innocent 13 year old child genius who made and honest mistake. I tried to get more information from him but he refused to provide any proof to verify his claims of either his age or his location such as a school or even the state he lived in.

6. Following this wrongful termination and new harassment I found myself for the first time ever as a successful software engineer unable to find a new job. During my job search one company in particular Fusion Alliance who had previously wanted to hire me, on more than one occasion in recent years (I have backup copies of email correspondence between myself and Fusion Alliance employees) was actively posting openings for positions on linked.com that fit well into my career experience however they suddenly no longer responded to my applications or emails.

I was eventually able to get an interview a short time later at two companies, one I did not get hired for but didn't notice anything odd about the interview process except that this company

was also connected to the medical industry and was doing mass spectrometry analysis software, however at my next interview at The Oddesy Online, I had a very unprofessional and unusual interview process. I was first left standing outside for 10 minutes past my interview start time, when I was finally allowed access into the building by an employee who was walking into the building. I was met with an empty dark room with only one person in it who first walked me upstairs to show me the rooftop and then backdown stairs and to the very back office with no lights on on the floor.

Where I met the interviewer Shawn Axios and another gentleman, during this interview Mr. Axios asked me very specific questions about how I felt about my previous supervisor at Springbuk, Mr. Steve Caldwell, they also asked me very specific questions about technologies that were not listed on my resume and they informed me they do not use those technologies anywhere in their tech stack. Following this I emailed Mr. Axios asking if he had been in contact with Mr. Caldwell or Springbuk since I had never had an interview experience like that before, or following that. Mr. Axios confirmed in those emails (that I have saved), that he had been in contact with Mr. Caldwell however he emphasized that his contact with Mr. Caldwall before my interview was because Mr. Caldwell wanted to hire him to work at Springbuk. Later on I noticed on github.com that Mr Axios was connected to several employees at Springbuk.

- 7. Following this I contacted a lawyer in the downtown Indianapolis area John Haskin and Associates hired their firm to file a complaint with the Equal Employment Opportunity Commission regarding this however the EEOC did not do any investigation, and I have backed up email copies of correspondence between myself and Shawn Axios after this interview where he confirmed he had been in direct contact with Steve Caldwell during the time of my interview however he emphasized the reason he was in contact with him was because Steve Caldwell was attempting to recruit him to work with Springbuk and not any sort of black listing arrangement or discussion about myself. The EEOC did not look into the matter or get any statements from either The Oddesy Online, or Fusion Alliance.
- 8. Since I was unable to find employment I was forced to find alternative means to generate income and started my own LLC and took on a custom software development project for a local company in the Indianapolis area named Offset House Printing, this project was Robert Bonjour's proposal and we discussed this at the American Legion located in Carmel Indiana, the verbal agreement we had was that he had existing customers that needed printing services for the real estate market however Offset House Printing did not have the money to afford to pay for a full custom application to be developed up front, he told me that if I built the software project that his existing customers would send over data to be processed with the application and I would make revenue from those orders, each order processed through the application would generate revenue for Offset House Printing company for the actual printing. Since I needed income and wasn't able to find new employment at the time, I agreed to build the project on the condition that he and Offset House would promote the product. After the initial test orders he sent over and processing of a few orders he / Offset House stopped promoting or

selling the product on their end, leaving me with the software project but no revenue to make up for its development cost.

9. Shortly before this new venture I received another anonymous package in the mail, the package was sent through UPS and the item was ordered from Amazon.com. I was able to find the sender by talking to multiple amazon support agents, I have some copies of this data including screenshots of my communications with Amazon support online chat, each gave me a little bit of the information I was given the first and last name by one amazon support agent and the city and state on the billing address from another amazon support agent.

They informed me that the sender was a person by the name of Benjamin Jones and the billing address on the package was located in Revere, MA.

Using a private investigator who wished to remain anonymous (I did not retain any records to identify them in respect of that wish). I was able to obtain confirm there was only one Benjamin Jones or Ben Jones in all of Revere, MA, this individuals name was Benjamin R. Jones and on his background report it showed this individuals work history and family information such as relatives / phone number etc. His most recent work history noted he was working as a production manager at the Hollywood Hall Of Fame in Cleveland, OH. This location was close geographically to where Mr. Caldwell was living, The package I received was a pair of stainless steel meat claws, before receiving this package in the mail I had no idea that meat claws were even a thing, evidently they are used by butchers to tear apart meat, I reported this incident to the Carmel police station at the time and was not taken seriously and there WAS NO report was taken as far as I know. I used the information from the anonymous private investigator to call Mr. Benjamin R Jones and asked him why he was sending me things in the mail, and then I asked him if he knew Steve Caldwell, he didn't deny that he sent things to me and instead asked how I got his contact information and he expressed that he was upset that amazon had revealed him and then he told me he wanted to get off the phone when I asked him if he knew Mr. Caldwell, that was the end of our phone conversation and I did not contact him again.

10. Around the same week from my office window I noticed an African American woman in a red car parked directly behind both of my vehicles from my apartment window taking pictures of my car license plates, this woman pulled forward and faced the front of her car towards the dumpster area and entered something into a tablet computer like an ipad or android tablet device she then backed up turning around then speeding past the stop sign going left on her way out of the neighborhood. I noted the license plate was a vanity plate that said "TRU2ME" and by using an online license plate search service the car was registered to a Ms. Carolyn Barnes with an address in Powell, Ohio. I still have copies of this license plate search result. I hired All In Investigations to look up who this woman was, they reported to me she is employed as an Occupation Therapist but I don't know which company or hospital employs her, this is another medical industry connection related to an illegal surveillance and appears to have been a pretext for further harassment I received.

- 11. Shortly after this I was contacted by a gentlemen who went by the name Chris S. Murphy, Chris contacted me via email and said he wanted to discuss using Hamsters.js software for his new business startup plans, I scheduled a phone call with him and spoke to him about the software. During the phone call he was very vague about who he was working with or what his business plan was, the only details he would give is that he worked with a group of people from MIT and that they were building an online trading platform, when I asked him what kind of platform he just told me they were calling it ECATRADE, his website at the time was called pacificcoastcommerce.com and he also had a public facebook profile for his former startup company called Park Street Media located in Boston, MA. Following the initial phone call I called him back to clarify a few questions and when he answered the phone he answered with the words "City Hall", from what I've read online this implies he was misrepresenting who he was during the initial call, and usually people who answer saying "City Hall" are connected to some municipality.
- 12. Several months later I was looking for new employment opportunities and living off my savings while trying to salvage the software project I made before to make it more usable so I could bring in revenue, by using the same recruiting company I had used to get hired at Springbuk.

I finally received a job offer as a Senior Software Engineer at a salary of \$104,000 per year at a local software company called 77media, LLC located in Broadripple, Indianapolis. The employees I worked with there were the co-founders Walter Botich, Dan Golnick, and Matt Long, and Becky Fisher (Her husbands name is Cory Fisher). There were two other employees who worked there briefly one named Mark Hosler on his resume at 77media, and he was never in the office except for one time, he showed up to an after hours infrstructure meeting wearing an IU Health Shirt, I immediately recognized him as the same Mark who had shown up at my apartment in the years prior to my employment at 77media, and didn't mention anything to him and he didn't say he knew me before, The other remote employee was an intern who was going to IUPUI at the time who I had help add some automated behavior tests using protractor to the 77media node.js application stack. I do not know that employees name.

During my employment part of my job duties were adding features/cleaning up the code stack/fixing bugs and managing their Microsoft Azure cloud application stack.

The software they were developing was an application called SafeSport, an online LMS (Learning Management Software) that was used by the United States Olympic Committee and Olympic athletes so they could complete online courses for things like sexual harassment training. I was not aware during my employment at 77media, LLC that there were on going congressional hearings regarding the Larry Nassar molestation scandal involving the United States Olympic Committee and the USA Gymnastics team.

13. During my employment one day I was working remotely and sitting on my couch using my work laptop PC, I had not been informed previously of any remote work monitoring software on the pc as it was purchased new when I joined the company as part of my employment offer however I got up to use the restroom one day and when I exited the bathroom door I noticed the

mouse cursor on my screen moving on its own and attempting to open a program I thought this was strange and scanned my work computer for malware and virus's using an avast antivirus boot time scan which did not detect any results. I later found a screenshot on the laptop where someone ran a norton virus scan, screen shotted it and saved it before the computer was purchased.

14. After this I checked to see if there was anything weird out of place as part of my job duties and maintaining the security of the code base and making sure nothing work critical was hacked or compromised, I checked the security settings in github as well as on my work pc and I did not find anything setup incorrectly however when inspecting the companies website I found code on the website that was loading data from another server.

The code was out of place and did not appear to have any functionality to any of the normal website functionality but included the words camera="true" microphone="true" location="true" vr="true", I have this data backed up as well. I asked Dan Golnick about this one day and he told me that the code was because they were doing a "Virtual Reality Health Education Program For IU Ruth Lilly Health Education Center", he then showed me a mobile phone application that loaded on the phone itself and not the company website, this mobile phone app was not a Virtual Reality program but actually an Augmented Reality program that overlayed food nutrition information when the phone camera looked at pictures of certain food. Several weeks prior to this Walter Botich and I had driven to the IU health building and had me wait in the car while he went inside for some business reason, I think it was to pick up a box of mobile phones which were used for the augmented reality program but I am unsure the exact reason he wanted me to go with him. These phones I later saw him with, they were white samsung phones and the application he showed me did not interface with that specific code on the 77media kipacity.com website.

15. During this time I continued to receive the majority of visits to my public linkedin.com profile from employees of my former employer Springbuk, employees at StrapHQ as well as an individual who went by the name of Syjon who pronounced his name as SenGen. This individual I had met back in 2014 at a local Irish pub Brockway Pub that I frequented near my old apartment complex Penn Circle apartments located in Carmel, IN. One of the first time I hung out with him he wrote on my notepad paper the words "Bilbo Baggins in the flesh", I thought this was a little odd but didn't really give it any consideration beyond that.

I became somewhat friends with this person during the time I worked at Springbuk and 77media he would almost always be at this pub anytime I was there as well as another older gentleman that drove a 2 door silver bmw 335i with tinted windows and said he lived in Chicago. When I first got hired at 77media Syjon encouraged me to update my linked in profile to reflect that I was now employed at 77media. I updated my linked in profile not giving it any thought and continued to hang out with him at Brockway pub on a semi regular basis. At the time I did not notice that the linkedin.com company profile was listed as a company based out of Saudi Arabia and not a company listed as in Indianapolis, however it had the same logo and the same name on linkedin. I believe that it may have actually originally said it was in

Indianapolis when I added it to my linkedin, this will become important context for later correspondence from Sengen.

16. I also continued to search for who could be behind the harassment and sending me weird stuff in the mail/blacklisting and up until this point I had thought everything was likely related to my previous employment at Springbuk and that Steve Caldwell was just upset with me and had his friend send me weird things to mess with me. However I eventually came across to a web page created by a guy named David Lee under a company named Arc90, this webpage was comparing my Hamsters.js software project to a few other similar software projects that do similar things but in different ways, I have this backed up as well. One of the projects that was being compared to my Hamsters.js software was a project named Catiline.js created by a guy named Calvin Metcalf who lives in Massachusetts, in the same geographical area (50 mi radius) as the Benjamin R. Jones information I received from the private investigator when I received the meat claws in the mail.

This Calvin person is connected to Paul Ford who is a co-founder for a software company located in New York City, New York called PostLight Studios, upon discovering this I looked over their website and noticed their clients included some big named clients including Goldman Sachs and other financial industry clients as well as software industry clients like Vice media, Mailchimp etc. I am not sure what other affiliations they have however they appear to be very well connected ie. they have clients with significant financial resources.

17. I ended up locating through the Postlight Studios website, the public twitter profile of the other co-founder of PostLight Studios who is named Paul Ford, Mr. Ford appears to be a software developer in the past and he has published articles in some tech magazines and appears to be a fairly successful individual however I had no prior contacts with him. Upon locating his twitter profile and adding PostLight Studios as an interest on LinkedIn, he posted on his twitter the exact words "You fucked up brand security and now you must die!", I didn't know who he was posting that to however I didn't have any reason at the time to believe it was about me and ignored it at the time.

A few days later I followed the PostLight studios linkedin company profile to see what they might be using my software for and I was also curious if they had any connection to the person who sent me the meat claws, upon doing this Mr. Ford began posting a large amount of threats and graphic images on his public twitter including a picture of a cross word puzzle that said the words "Exterminate Smith" with only a few of the letters hidden. He also posted things including "We were in your house today for extermination" and "You could be anything you wanted and you chose vegetable!" and just other generally bizarre things including sharing pictures between Calvin MetCalf and himself of a Hamster with an eye ball coming out of its mouth, this to me suggests they were doing corporate espionage where they were working to discredit or stop the success of the Hamsters.js project through illegal manners.

This was a cause of alarm for me and I took screenshots of this however initially I did not take it very seriously as I had been threatened several times in the past online and usually its just

people talking crap and nothing comes of it. However this person I had no previously contact with and therefore had no expectation of any confrontation with them. I attempted to create a twitter account so that I could get more information on who they were and communicate with them however immediately upon creating a brand new twitter account my twitter accounts were suspended preventing me from interacting with him. These account blocking messages were signed with the Google logo, and not a twitter logo. I have backed up some of these tweets however it appears that he deleted the picture of the crossword puzzle and most of the posts he made that day, he also had posted previously pictures that Hamster with an eye ball in its mouth but he deleted those posts from his public twitter profile, I don't know how to get deleted tweets, I tried to get a court to subpeona twitter for these tweets but I was obstructed by the Southern District Court located in Indianapolis, they misfiled several paperwork documents, omitted dates and omitted signatures on the documents, additionally they denied me a waiver for the \$400 fee they requested to process my lawsuit.

- 18. The following day of receiving those threats online I went about my life as normal and worked like normal, after work I drove to the local Irish Pub Brockway Pub where I ran into Syjon and a guy named Kevin Paul (KP) who made several vague comments about watching a show the night before but he didn't explain what he was talking about, Syjon also made comments including "You don't know what's really going on" and "Don't start something there won't be something", I brushed these comments off as he had a history of being politically incorrect and just sometimes saying rude things / being an asshole in general so it wasn't out of character of him to act weird and I didn't give it any thought beyond that. An employee of the Indiana department of transporation who also frequently went to Brockway Pub, told me to not talk about what had happened, and asked me if I was going to "let it go.", I don't know why he would say these things but that seemed to me like intimidation of a victim.
- 19. That night I walked home from Brockway pub because I had a few too many beers and I didn't want to risk driving even though it was a short drive, I stopped at the liquor store on the way home and bought a small bottle of bourbon, as I was walking home and approaching the rounda-bout in front of my apartment complex and the MISO electric building I noticed someone was recording me with a quad rotor rc drone with a green flashing light at the top, it was hovering approximately 7-10 feet off of the ground with the camera of the drone looking directly at me. I showed the camera the middle finger and the operator flew the drone back to where they were parked which was the apartment complex across the street from the apartment complex I was staying in and they sped away quickly in a blueish gray honda insight minivan. I reported this incident to Carmel police the following day however they did not take me seriously and did not make a report in their system. I asked them to check the MISO electric utility plant cameras as they have very high security at that building and that footage from MISO would have validated my claims however as has been a pattern during this harassment, no one has ever assisted, they hae only tried to obstruct or harm.
- 20. I decided not to return to my employment at 77media the following day and instead spent time around family members trying to explain what had happened, my brother was contacted by Walter Botich looking for me who at the time had not heard from me.

- 21. Later that day I returned back to my apartment and showered and refrained from talking to anyone, and ate something walked my dog and did some cleaning around my apartment and went to bed.
- 22. The following day I was contacted by Syjon asking me to come out to Brockway Pub for lunch and some drinks, I ate some chicken wings that day but didn't drink any alcohol, we sat at a small circular booth table directly right to the door of the pub, he was facing towards the bar/kitchen area and I was sitting to the right of him during this lunch I was casually talking about how I think I'd found out the people who were harassing me online and before I could explain the rest of what had happened he told me not to talk about it and reiterated that I didn't know what was going on.
- 23. The following day was trivia night at Brockway Pub so I think I went there, and was drinking with Syjon and KP while playing trivia Syjon made a point to ask me to come over so he could tell me about some guy in the bar who he said was "Worth a lot shekels", he pointed at a guy sitting by himself who was sitting in a booth facing towards the back of the bar and was directly to the right of the left side of the bar, but Syjon did not tell his name, I remember him wearing all dark tan and he was bald. I still do not have any idea what he meant by this. I dismissed this at the time as Syjon just being weird again and continued drinking at Brockway pub. Looking back on this, I have not been able to identify the clothing he was wearing as connected to any known entity. I previously served for a short time in the Army National Guard and during my time we wore ACU's and I don't recognize this guys outfit as belonging to any known military uniform of the United States, it doesn't match Marine Corp, doesn't match Army, doesn't Match Navy, doesn't Match Air Force, this guys attire was out of place. It also didn't match any known sherif or police uniform that I had seen in my lifetime.
- 24. I took an Uber back from Brockway that night and the following days started looking for another job.
- 25. Later in April or Late March 2018 following all these events, I was sitting in my apartment and was on my laptop computer either programming or looking for a new job and someone tried to break into my apartment, I heard them try to open the door and saw the door handle moving too fortunately the deadbolt stopped them and they then ran quickly down the apartment stairs, and drove quickly out of the neighborhood they were driving a black mercury milan 4 door sedan, I reported this incident to my apartment complex at the time when it happened. Looking back on this incident the car they were driving was in the same parking spot as neighbors on the same floor however the apartment maintenance guy also jumped into the car with them which seems strange.

- 26. I think the following day Syjon came over and we went to brockway pub to have a few beers and hang out in the afternoon, nothing unusual happened that day.
- 27. The next day I noticed something really strange outside of my apartment while I was cleaning up the area my dog played in and I had my apartment porch door open, this incident was just out of place / bizarre and I wasn't sure if it there was some sort of school play thing going on however a family of people with two kids dressed up in peter pan and tinker bell costumes holding a cutout of a dark grey shadow ghost took pictures in front of the apartment complex sign directly in front of my apartment. This was just weird because it wasn't Halloween and I didn't think school was in session since it was June already so I tried to ask the Carmel Police department if they had any idea of a school play going on or something so I could get some sort of explanation but they said they had no idea. I think I went back to my apartment and finished cleaning up and then went over to my aunts that day and played fortnite on the computer with my brother as he was living with my aunt in 2018.
- 28. The following day I was driving in my 1996 Toyota Supra heading northbound on 465 heading towards Carmel from my aunts because I had stayed the night there and noticed a yellow jeep wrangler driving a few car lengths behind me waving at me. I slowed down because I do not know anyone who drives a jeep wrangler and waved back and he picked up a black cell phone or radio a security guard would use and spoke into it. At this point I was concerned because of the previous threats I had received online and wasn't sure who the individual was, at this point I felt the need to report what had happened previously including the information about 77media/PostLight Studios et. all and I passed my normal exit on meridian street and got off at the Castleton street exit, while I was stopped at the traffic light to turn left a female driver in a black 4 door sedan waved at me, so I at this point I actually attempted to report the threats and weird jeep driver to the Fishers Police department however I was turned away at the time and not taken seriously.
- 29. The following day I decided instead to report the threats I had received to the local FBI field office, I spoke with a male field agent however I do not know his name, he took down several notes and I explained to him the people who had sent me the strange package in the mail as well as the weird posts Paul Ford and his cohorts had made including the cross word puzzle picture with the words Exterminate Smith on them, the field agent told me to make sure to check my apartment for cameras or anything out of place, I returned back to my apartment anticipating they would contact me at a later time, I did a brief look around and didn't see anything weird in my apartment aside from a few holes in the plaster of my apartment ceiling.
- 30. A few days later I think I went back over to my aunts house and was hanging out with my aunt and brother and while I was there I received a text message from Syjon stating "You figured out my kind, pretty good", I didn't immediately respond to this but instead left my aunts house to head back to my apartment. I was driving my black 2001 Jaguar XJ8 at the time, I was driving on 465 heading north when I received a call from Robert Bonjour asking me to come over to his house that night to hang out, I was on my way there but stopped by my sisters house to make sure they were ok since I had received a strange text from Syjon and death threats and was

wanting to makes sure they were safe. The text he had sent me said "You figured out my kind, pretty good.", I responded back to him "Kind?" because I didn't understand what he meant, he responded back to me "Kind, we call it kind", when I responded to him to see how he would respond and I also had sucspicions that him having me add 77media on my linkedin may have been some sort of attempt at parallel construction, I said "Your mistake was being the one who told me to update my linked in profile", this was just my suspicion that something was connected between him and my employment at 77media, and he responded with "You made many many mistakes". I didn't know what he meant by that is when I called Fishers Police department and spoke to the dispatcher on the phone and tried to explain the situation but I don't think I was taken seriously.

31. Instead of reviewing the evidence I offered them including the text messages that were sent from Syjon to me and my text messages back to him and giving an opportunity to actually explain what happened, fishers police placed me in handcuffs, and in the police report and CAD narrative misrepresented the facts of the incident by falsely claiming the text messages were sent to myself by myself and that I was claiming that the "FBI was out to get me" that was hearsay and and not what I said, my only comment to anyone of my family members, friends, and any member of law enforcement was that I had reported the threats to the FBI.

Additionally I have copies of the CAD notes however they were damaged when my car caught fire while driving earlier this year, in the CAD notes it misrepresents the incident and did not include that I had attempted to report a few of the previous incidents to police before and was ignored.

- 32. Police placed me into handcuffs and confiscated my belongings from my vehicle without my permission or a warrant, I repeatedly told them no however they refused to accept my refusal for them to search my car and took my property anyway. They took me to Community North hospital located in Castleton, Indiana and wanted me to stay for a 72-hour hold even though I was non violent and completely calm and had no criminal history or history of violence. As I explain later in this timeline of events, Community North had a conflict of interests as they owe me money for medical malpractice and they also have connections through my former employer 77media!
- 33. During this time I explained very calmly to the intake person why I had called 9/11 that evening, the intake person I do not think took my claims credibly and immediately I was placed in a basement ward area that was dark and I was not provided with any copies of the hospitals policies or patient consent forms, upon requesting a copy of my patient rights I was told my stay had been extended an additional 48 hours and when I requested access to my wallet so I could contact an attorney that I had contacted prior to me calling 9/11 my request was denied.
- 34. During this time there was another patient there who threatened me and repeatedly made comments to me saying "They come in hot and leave cold as in on a slab" and I told the staff that I did not like his comments and asked if they recorded audio so that a staff could review and they did not do that, they told me that they do not record audio , instead of taking my report

of the threats seriously they instead had me share a room with the same person who was threatening me, the guy who threatened me during my time there told me he was a nurse at IU and that he would "go on secret missions and liked them and he told me he thought his secret missions were fun to him", this made me uncomfortable and I feel the staff should not have had me share a room with someone I had previously reported was making death threats.

- 35. During my stay I was polite and cordial with the hospital staff however they refused to release me even after the initial 72-hours and instead when the 72-hours came and went, then the extra 48 hours added for requesting the patient policy forms they again extended my stay an additional 72-hours without cause. When I requested again to leave they instead filed a petition to keep me for an additional 90 days without cause or any reason whatsoever, the hospital staff also tried to force me to take psychiatric medication without my consent and when I refused this is when they filed to keep me for an additional 90 days. Eventually I had my day in the probate court at the Marion County courthouse in downtown Indianapolis where the probate judge denied Community North's and the State of Indiana's request to commit me and stated clearly that I am not a danger to myself nor am I a danger to anyone.
- 36. During this time I was stuck against my will in Community North for contacting the Fishers Police department, the State of Indiana and Hamilton County filed a petition to permanently deprive me of my 2nd amendment firearms rights without cause. They had taken my firearms from the trunk in my vehicle as my plan earlier in the day was to go to the range that day because I had a monthly membership at Shoot Point Blank in Carmel Indiana at the time. These papers were not properly filed through the court system and they were never properly served to me, I did not even hear about them until the day before my court hearing to be released from community north. Instead they were left outside on my apartment door in a manila envelope, legally I believe any paperwork like that is supposed to be properly served to someone and not dropped in front of their door without notice.
- 37. Once I was finally released from Community North hospital I hired 2nd amendment and constitutional attorney Guy Relford of Relford Law to defend me against this illegal and unwarranted deprivation of my rights, I repeatedly requested to have a hearing so I could get the evidence in my possession on the official court record and clear my reputation and return my firearms back to me however that never happened. Instead I was advised that he was good friends with the prosecutor and that if I just answer the questionnaires (ignoring procedural violations in the process like not properly serving the paperwork) and attend a firearm safety course at my expense that I would get my firearms back. Mr. Relford offered to do this firearm training safety course for me since he is also a firearms instructor however when the day came for me to attend the course Mr. Relford did not tell me the time nor the address and when I followed up with him later that morning he told me that I had missed it and it was at 6:30am that day. This seems like an odd time for a firearms safety course, I don't believe the sun is even up that early. This further delayed me getting my firearms back and instead I signed up and paid for a firearm safety course through Shoot Point Blank and completed the firearm safety course through them. I provided Mr. Relford this proof of the safety course completion and I had my

my firearms returned however the total process was almost a year in total without any hearing which from what I read is atypical and the law states anyone deprived of their 2nd amendment through such a process is entitled to a hearing within a short time period which this law was violated by the state and Hamilton county. Also this costs me almost \$5000 in total, which is ridiculous as I was the victim of a crime, not a perpetrator of a crime.

- 38. I attempted to seek legal counsel from many places during the following weeks, I was denied assistance at every entity I spoke to and denied assistance by pretty much every lawyer I spoke to as well. I kept a list of who I contacted, I was even denied by the State Attorney Generals office any assistance and told they would only represent the state of Indiana.
- 39. Following this since I did not have employment and I did not have any way to get any assistance for what had happened I lived off of my life savings and moved to Avon, Indiana with my brother.
- 40. During my time living in Avon, I've tried to move on with my normal life since I was effectively denied recourse at every turn and I had been employed as a Software Engineering Manager/ Software Project Manager at a company located in Fort Wayne, Indiana called CodeClouds, I worked at CodeClouds for over almost two years however earning roughly 50% of what I made annually before. Harassment has continued in other ways however again none of the evidence has been reviewed by anyone (to my knowledge) even when offered a flash drive containing it... Most recently someone put their used chewing gum on the side of the truck while I was painting when the paint was still drying, I don't know who did this but the strange harassment hasn't completely stopped. Additionally my aunt passed away from what was reported as a self inflicted gun shot wound to the head, before her death she had told me in person during thanksgiving that someone had shown up outside her house and knocked on her door and asked her if she worked with or was a police officer, the guy who showed up at her place then told her he had a lot of guns and then he laid down in front of her house and put his hands behind his back and then after laying there for a short time he got up and left. My aunt also told me that she had received a strange phone call from someone claiming to be the FBI and that she was in danger and they told her she was the victim of a mortgage fraud attempt and then about two or three years later she passed away. Upon her passing, her daughter (my cousin) Brenna met with me and my family and Brenna and I checked for documents and flash drives and hard drives that I handed to my aunt back in 2018 for safe keeping, these documents and drives contained data validating my claims regarding 77media, Fishers Productions, Post Light Studios, IU Health, and death threats I had received from people employed by Post Light Studios, my cousin and I looked everywhere and were unable to find these documents or drives, my cousin later checked my aunts work office and her work safe and car and none of these items were recovered, this to me suggests someone who arrived when she was taken to the hospital or while she was in the hospital, took these items from her place, there doesn't appear to be any legitimate reason that these items would be taken from her place, she passed away from a suicide and why would someone take documents or drives showing a corrupt attempt to harm me, from my aunts? This suggests a cover up attempt by someone who doesn't want the

77media situation to be exposed. Some of these documents were also faxed by my aunt to Community North Hospital back in 2018, the hospital back then even when faxed information validating my claims regarding the threats I had received and reported still attempted to keep me in the hospital for 3 months, also the original attempt to keep me at the hospital was only supposed to be for two days, when I requested a copy of patient hospital rights they retaliated and extended my stay and then I received death threats by a Nurse who worked for IU Health during my stay, he repeatedly told me the words "They come in hot and leave cold, like on a slab". I reported this to the hospital staff and instead of separating him so he couldn't threaten people they had me share a room with the guy I reported was threatening me.

- 41. Additionally to all of the attempts to seek local assistance I submitted several FOIA requests to the FBI attempting to get any information they may have about what I reported and if there is any connection to my employment at 77media, every FOIA request I submitted was denied except one. The FBI sent a DVD however I have not reviewed what information it contains. I maintained copies of every individuals information that I know 100% is involved in some manner including for some of them their addresses and contact information however I also saved screenshots of their twitter profiles, linked in profiles, github profiles, and for Paul Ford his entire twitter post history since he created his account up until today, if needed I can pull the data again and get the most recent posts. I also saved copies of the postlight studios website in original format and the 77media website in original format. This evidence was backed up on multiple drives, and cloud storage providers. Additionally all text messages between myself and Syjon the day I contacted police department were supposed to be stored on an encrypted Iphone 6+, however I recently in 2025 paid a private investigator called All In Investigations to decrypt the phone and recover the data, I have the data backup from that phone however the text messages appeared to have been wiped from the phone and there was also images on the phone that I havent seen before like animated short videos of people boarding airplanes and stuff like that, the text messages appear to have been wiped in 2021 and it seems like someone either physically accessed the phone without my knowledge, or it was remotely accessed without my knowledge and data was wiped from the phone. This to me suggests someone didn't want me to have the text messages that came from Syjion Shaefer in 2018.
- 42. I should also note that my dad was employed at the Department of public works when I filed my lawsuit against Hamilton County and other parties involved in the 77media scandal, my dad was terminated from his employment during the next several days and wasnt able to find employment since. He later committed suicide by drinking himself to death using whiskey and believed it was pointless to continue, also Westfield Police before his death illegally entered his apartment and searched the place without warrant, and then also took a case of his beer out of the fridge with them, when they left his apartment. This is not legal behavior, and is unbecoming of an officer to be drinking citizens beers or taking things from anyone's place without a warrant specifically listing the items to be seized.
- 43. Additionally I found out that Walter Botich, and Cory Fisher are both connected to a medical intelligence agency in the Indianapolis area that is named the Mesh Coalition, evidently they

work with hospitals such as IU North, Community North, and medical industry companies/insurance companies. Cory Fisher has a public vimeo page detailing how the Indiana Mesh Coalitions intelligence tools rival that of federal intelligent agencies. I backed up copies of these videos. A yahoo search result shows Walter Botich is connected to the Indiana Mesh Coalition.

- 44. I've attempted to think of what a valid motive any of these people might have to engage in such behavior as I wasn't thinking I had done anything worth anyone harassing or drugging me or any other attempt to cause harm to myself/family members, It's possible that some of them have different motivations, I honestly can't think of any valid reason other than potentially greed due to the software connection between Postlight Studios, and Calvin Metcalf as he was the developer of a competing software product, has a direct connection to Postlight studios and even retweeted Paul Fords posts.
- 45. I later learned several years after I reported incidents in 2018, as I was watching Fox59 news, it was reported that the director of the local FBI field office and several of the agents in Castleton were implicated in the USA Gymnastics, Larry Nassar molestation controversy with the several of the local field office facing criminal charges because instead of investigating and prosecuting the sexual offenders they engaged in a systemic cover up in exchange for a promised job at the US Olympic Committee. Additionally the field agents at the FBI mocked the girls who were abused by the Doctor Larry Nassar and obstructed them from being able to receive any restitution for the abuse they suffered, this to me is downright disgusting and unbecoming of anyone in any position of authority. This was a big scandal that led to congressional hearings too, I had no prior knowledge of this scandal during my employment at 77media. I just recently read more details about this scandal and the reports say that Nassar abused over 250 girls and I did not realize how big of a molestation scandal that was, individuals connected to Nassar were still being prosecuted between the years of 2018 and 2021, allegedly there were supposed to be reforms at the Castleton Field Office but it appears they are still mocking and working to discredit victims. Ever since my report to the Castleton Field Office Ive received increase harassment including auditory harassment from people, I put together some python programming language scripts that record raw audio using a 15hz-20khz USB Microphone, and this script takes the raw audio, and then runs it through several transformations, it does binaural audio phase shifting, am demodulation, fm demodulation, sbb demodulation, and runs all versions of the audio through a speech to text program, it does fast furior transform frequency analysis and logs the frequency of the audio along with any detected speech to an excel file. I've managed to record quite a bit of the audio, in the audio ive recorded these people were recorded talking about manslaughter and other horrible things, they appear to have been planning to do some sort of bad thing and Ive got all the audio data in raw format.
- 46. Additionally there was several incidents around the years of 2013-2017 where multiple people attempted to run me off the rode or cause a car accident with me, this happened on residential roads going through round abouts / intersections and also while I was driving on the highway. I reported these incidents as well and did not think these incidents were connected to the other harassment I had received at the time.

- 47. Also my late father who was riding a moped scooter was also hit by a car while going through an intersection, I'm not sure if this is connected however it seems strange to have so many car related incidents happen to myself or family over a period of only a few years. This incident was not the reason for his death, he ended up drinking himself to the point of liver failure following him losing his source of income, before losing his source of income he was employed by Fishers Department of Public Works, he was fired only a few days after I filed a lawsuit against Hamilton County for violating my rights and illegally holding my firearms beyond the legal limits and also falsely accusing me of mental illness and doing a cover up of the 77media, USOC, PostLight Studios, IU Health, Mesh Coaltion, Fishers Productions group. This to me suggests a RICO Statute level conglomerate working to discredit victims.
- 48. Additionally during the years between 2013-2017, myself and friends and family members have all been drugged by strangers while out at a bar/resturant and even at a campground in Monticello, far away from any bar or resturant. I personally know I've been roofied at least 5 times that I know of, and my brother has been roofied at least 2 times that he knows about and my friend Sam was also roofied while out with my brother and woke up under an overpass, Carmel Police called my brother telling him they had found my friend Sams bicycle. In 2017 One of these incidents was while at Brockway Pub, I was drinking an irish mule and there was a guy sitting to the left of me and we were talking and somehow we got on the subject of who can drink the most, and I got up to use the bathroom not thinking anything was amiss and when I came back he was gone and I finished my drink, later the following day I was told by Synjin and others that I seemed really messed up and didn't seem like I was drunk and I had not drank that much, I was also told by my neighbor that I was walking my dog and kept falling down and couldn't standup that night, the following day when I went back to the bar they told me that they had the facebook profile of the person who drugged me and even showed me his facebook profile picture, this seemed out of place and weird that someone at the brockway pub would actually have the guys facebook profile on their phone. Additionally I mention in this document that my dad told me back in 2007-2008 that he was injected with something by a woman who said she was a firefighters girlfriend or wife at a restaurant in Westfield.
- 49. Additionally between the years of 2016-2018 I dated a girl who was previously married to a diplomat, the only things I was told about him was that he was living outside the country and they were separated. I dated this woman for several years, we had a great relationship and I helped take care of her and her daughter and covered the rent and utilities and entertainment for the household. We eventually broke up due to her cheating on me however I got back together with her at one point, and then we weren't able to get past the trust issues so we separated and she dated someone else and moved out of state.
- 50. During recent years I've been being harassed with auditory harassment, I was also battered by a Fishers Police officer who lied in his report and said I didn't use my turn signal which I had used my turn signal and then he also lied and said I yelled at him, and lied and said I kicked him, and instead what happened was he kneed me in the chest and tried to knee me the first time and kneed either the other officer or failed to knee me in the chest and then he kneed me in the

chest, and then pushed me forward where I hit my head on the pavement. He yelled at me that he was a marine and I had to hire a lawyer which cost me \$7500 this lawyer never informed me of what the actual claim was against me, I was only told they were saying I had battered a public safety official but I was never informed of what the claim of battery was until I was in the hamitlon county court room and they asked how I plead to their false claim. This to me is insane and not a proper way to handle a situation like that, my lawyer should have informed me of the claim, my lawyer also barely communicated with me and didn't even tell me what my options were until 5 minutes before the hearing. As mentioned above, I receive auditory harassment that I hadnt notice before I reported the things I was a victim of to the FBI, I also received strange text messages from people claiming to be federal agents, and then also I noticed an SUV only a few days ago on april 8th, of a metallic suv with vanity plates on the back and a USS license plate on the front, this person in the SUV was meeting with one of my neighbors in broadripple.

- 51. The individuals involved in this intimidation and discreditation campaign also hacked my laptop computers, they spake through my work laptop while I was employed at Herring Bank remotely building FinTech software, this hackers mentioned me going to a doctors appointment when I had talked to my brother about going to an appointment and I recorded these people talking through my work computer and I have proof that they hacked my work computer, this was reported to my employer who then laid me off from my job without requesting copies of the audio recording validating my claims. This seems odd to me that they wouldn't want a copy of proof of someone hacking a bank employees computer, I believe there might be financial regulations or laws that require them to preserve copies of any data breach of a bank computer.
- 52. An independent psychological evaluation has confirmed that I am not mentally ill and am not a candidate for any psychiatric treatment or medication, additionally during the years of 2012-2016 I pursued a work comp claim against Walgreens and Sedgewick CMS, during this work comp claim the state of Indiana validated that I am a credible witness and that I was successful in validating my claims against Walgreens/Sedgewick CMS and Sedgewick CMS settled with me and paid me a sum of money in order to end the work comp claim.
- 53. Additionally I am going to have to pursue legal action against Community North as the medication they prescribed me during the harassment I received, had a side effect that I was never informed about which was parkisons like shaking of my right arm and shoulder, and also has caused the development of breast tissue, I've never been informed that these side effects were possible and this to me is medical malpractice, I read online that the medication had been recalled and was litigated against due to these side effects where the medical industry has had to pay large sums of money for the harm they've caused. This campaign against me is unwarranted and illegal and unconstitutional, its been an institutional effort to discredit my claims and according to Mr. Fords words "exterminate", this program being run through IU and 77media and their cohorts appears to be a secret program which is similar to cointel pro programs however this appears to be worse than I originally thought as not only has the RICO style entities been working to discredit, they've mocked me, they've told me they intend to set me up, they've also told me they wanted to kill me, I received threats online where people said

things like "We're going to put a bullet in your head, your families head, and your dogs head", also they've said things like "When you mess with the police someone gotta die", and other horrible things, they've tormented me with auditory and made false accusations and everytime I report the harassment or illegal things Im a victim of, they try to discredit me further or hack my computers, or even do things like take trash from the curb and put it on my front porch. I had to move out of my rental in broadripple due to these disruptions, also I noticed that my financial records seem to have been tampered with, as I received a zelle payment from my friend Robert Bonjour who lent me some money to pay my bills, the financial transaction should have shown it came from Zelle through his PNC bank, however it now shows something called Qpay which ive never heard of before.

- 54. All In Investigations was also hired to figure out who this Mark Hosler guy really is as he followed me to another employer in Ft. Wayne Indiana called CodeClouds which was previously branded as LongTail Technology which if I recall was a name connected to Amazon the company, the CodeClouds company is almost 3 hours away from the broadripple 77media office and Mark Hosler showed up there as a remote employee living in broadripple he used the last name Hoser at CodeClouds and Hosler at 77media, upon the PI telling me this information I headed back to my rental in broadripple and stopped at a gas station and upon leaving the gas station Mark followed me in his car all the way to the intersection of broadripple ave, and winthrop ave, I tried to take a picture of him tailing me however when I tried to take a picture they slowed way down and made it very hard to get a picture of them, then they stopped and let people out of the mcdonalds parking lot, even though if they continued driving they wouldn't have blocked anyone from leaving the parking lot, this suggests to me they wanted to make sure there were cars between them and my vehicle. This Mark Character keeps showing up throughout the last 9 years and he repeatedly shows up wearing IU branded clothing. He's connected through 77media to IU and employees of the Mesh Coalition.
- 55. These individual and companies appear to have been in a multiple year long attempt to essentially eliminate me from society and discredit me, steal intellectual property from me, hide their exposure by stealing things from my aunts place, and also threaten me with death. This is psychopathic systemic corruption, no sane society should accept any group involved in such a scheme.
- 56. Additionally local Indianapolis, Fox59 news has been broadcasting some fake news stories that I noticed, one such news broadcast falsely claimed a person I worked with at Moser Consulting/Westlake Design/Westlake Interactive, Natalie Fisher, was missing. The following day I asked my other former co-worker Alex Howard if she was ok because I saw that on the news broadcast, he told me she was fine and at work that day and wasn't missing. This was very odd that Fox59 would broadcast a missing person report about someone who wasnt even missing. This seemed strange to me that they would be broadcasting such fake stories, before my reports of the harassment I had not noticed such obviously fake stories from Fox59.

- 57. I want to also note, that before my employment at 77media in 2017 and my friends at the time we met up at Jeffery Mcclures house and we went out downtown to have some drinks and I met one of Jeffs friends and was talking to her and I mentioned to her how I was going to be working with Dan Golnick and she seemed to know who Dan was and said that I shouldn't work with him. I don't know what that girl was concerned about back then or what she had previously heard but had I known he was connected to such corruption I would have refused to work at 77media.
- 58. As of April 29th, 2025 I cleaned out my truck and found that my trucks electronics have been modified heavily, the truck is a 1989 Nissan D21 Pickup Truck however the ECU in the truck was replaced in August 2022 without my knowledge or consent, I strongly suspect this occurred when I had my truck clear-coated at a shop right next door to the Hendricks County Sheriffs department building.
